1. Taylor Business Institute received funding from the federal government for a grant under the CARES ACT as part of the Higher Education Emergency Relief Fund (HEERF). The school signed and returned the Certification and Agreement as of May 5, 2020 as required under the CARES Act with its assurance that the school will use no less than 50% of the CARES Act funds for Emergency Financial Aid Grants to students.
2. The total amount received from the HEERF as part of the CARES Act Emergency Financial Aid Grants to Students was \$91,766. This funding will be disbursed as emergency checks to eligible students in need who were enrolled, as of March 13, 2020, are currently enrolled or may enroll during this time of disruption.
3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of May 5, 2020, the date of submission (i.e., as of the 30-day report and every 45 days thereafter).
  - \$0 as of the 30-day report, June 4, 2020
  - \$36,000 as of the date of distribution June 17, 2020.
  - \$57,000 as of the date of distribution August 31, 2020
  - \$60,000 as of the end of Quarter 1 September 30, 2020
  - \$70,500 as of the end of Quarter 2 December 31, 2020
  - \$82,500 as of the end of Quarter 3 March 31, 2021
4. The estimated total number of students at the institutions who are or could be eligible to participate in the Federal student financial aid programs under Section 484 of the Higher Education Act of 1965 as amended, and thus are eligible to receive Emergency Financial Aid Grants to students under Section 1804(a)(1) of the CARES Act.
  - 45 students
5. The total number of students that have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act.
  - 40 students as of March 10, 2021

6. The method used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act:
- The Department of Education has given colleges and universities discretion to determine how this emergency assistance will be disbursed to eligible students. Understanding that many of TBI students have experienced financial hardships as a result of the pandemic, Taylor Business Institute's intention is to ensure that students with the most urgent needs are the first to receive the emergency grant funds. In accordance with the directive from Education Secretary Betsy DeVos, institutions are to prioritize funding for those students with the greatest needs, while distributing grants as widely as possible for maximum impact. The distribution of grants to eligible students is as follows:
  - The institute will base its grant distribution on Pell eligibility. Those students with an EFC of zero, will be the most in need, and will receive \$1500.
  - A Pell eligible student with an EFC greater than zero will be considered for grant funds after those with an EFC of zero
